Regarding establishment of new schools on self-finance basis under the Maharashtra Self-Finance Schools (Establishment and Regulation) Act, 2012, as well as regarding grant of permission for up gradation of existing schools for the academic year 2018-19.

With reference to the above said subject, it is informed to you that, you have filed a proposal for establishment of new schools on self-finance basis under The Maharashtra Self-Finance Schools (Establishment and Regulation) Act, 2012, as well as regarding grant of permission for up gradation of existing schools for the academic year 2018-19. Therefore as per your proposal sanction is granted under The Maharashtra Self-Finance Schools (Establishment and Regulation) Act, 2012 (1st of 2013) for establishment of new schools as well as regarding grant of permission for up gradation of existing schools for the academic year 2018-19 subject to the compliance of following conditions....

Terins & Conditions

1) The institution shall submit new Challan of Rs. 30,000/-, Fixed Deposit of Rs. 5,00,000/- for the term of 3 years along with updated bank balance certificate (with minimum balance of Rs. 1 lakh) to the Divisional Deputy Director of Education, Aurangabad within 3 months. If the compliance is not made, the permission given by the government will automatically be considered as cancelled.

2) The said school shall comply with the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and all rules/provisions prescribed

thereunder from time to time.

3) The permission is granted in view of Ref.No.2. If the institution does not have all the necessary things as per the prescribed provisions of The Maharashtra Self-Finance Schools (Establishment and Regulation) Act, 2012, then the institution must comply all the requirements in view of Ref.No.2 and shall start the school within 18 month from the date of GR, otherwise it will be treated as cancelled.

4) The concerned competent authorities should ensure that the provisions of The Maharashtra Self-Finance Schools (Establishment and Regulation) Act, 2012 are

complied with and only then take further action regarding first approval.

5) It is not allowed to change in the medium, school location etc. sought by the institution for school permission. If the school is started at a place other than the place where permission has been given by the government, the permission given by the government will automatically be considered as cancelled.

6) The above sanctioned/upgraded schools shall follow:-

The orders and procedures issued from Government, and

The provisions of The Maharashtra Self-Finance Schools (Establishment ii)

and Regulation) Act, 2012.

7) The Education Officer (Primary/Secondary) should ensure that the provisions of Act of 2009 are complied with and only then take further action regarding first approval.

8) It is not allowed to change in the medium, school location etc. sought by the institution for school permission. If the school is started at a place other than the place where permission has been given by the government, the permission given by

the government will automatically be considered as cancelled.

9) U-DISE Data:- While filling the district wise information in U-DISE (Unified District Information System for Education) about the new schools / up gradation of schools permitted by this Government decision, by recording in a separate category as "permitted schools on self-finance basis" the responsibility of obtaining the U-DISE number will be on the concerned organization. State Project Director, Maharashtra Primary Education Council, Mumbai has been declared as the Nodal Officer to take further action in this regard. Similarly, the institution shall be R Salis Colons & Colo

required to put up a notice boar I outside the entrance of the school stating "New School Permitted on Self-Supporting Basis / School Permitted for Up gradation" for the information of all concerned.

- 10) All the upgraded schools shall have all physical facilities. All the standards as per the RTE Act 2009 shall be strictly complied regarding primary schools. So also the Education officer (primary/ secondary) shall ensure the following requirements as per government resolution order number 3.
 - (1) The land proposed by School should be minimum 1 acre in continuation/ or suitable for school as per land rules. The proposed land is not found as per rules, then a proposal shall be sent to government cancellation of Grant of school.
 - (2) Donation fund (fixed deposit) shall be in the name of school for the period of 03 years since the filing of proposal for grant of school. Thereafter said FD shall be kept with Education officer (primary/ secondary) as mortgage. Thus the sanction is granted under The Maharashtra Self-Finance Schools (Establishment and Regulation) Act, 2012 for establishment of new schools as well as regarding grant of permission for up gradation of existing schools since the academic year 2018-19.
